SUBJECT: Updates to the Healthcare Common Procedure Coding System (HCPCS)

EFFECTIVE: Additions Effective for Claims with Dates of Service on or after January 1, 2002

PURPOSE: To notify podiatrists of additions to the 2002 Healthcare Common Procedure Coding System (HCPCS) and reimbursement for Medicaid and NJ FamilyCare fee-for-service covered medical services.

ACTION: The New Jersey Division of Medical Assistance and Health Services (DMAHS) has added new HCPCS procedure codes and their applicable maximum fee allowances. These procedure codes reflect podiatry services and maximum fee allowances, which are reimbursable to podiatrists by the New Jersey Medicaid and NJ FamilyCare programs. Providers should use these HCPCS procedure codes when submitting claims for processing.
