**TO:** Providers of Pharmaceutical Services

**SUBJECT:** Eligibility Limits for Calendar Year 2015 for Pharmaceutical Assistance to the Aged and Disabled (PAAD), Lifeline, Hearing Aid Assistance to the Aged and Disabled (HAAAD), and Senior Gold Discount Prescription Program.

**EFFECTIVE:** January 1, 2015

**PURPOSE:** To notify providers, beneficiaries and the general public of the new income eligibility limits for calendar year 2015 for PAAD, Lifeline, HAAAD, and Senior Gold.

**BACKGROUND:** In accordance with N.J.S.A. 30:4D-21 b, eligibility limits are adjusted each year to reflect the amount of the Social Security cost of living adjustment (COLA).

The COLA for calendar year 2015 is **1.7%**. Based on the COLA, the PAAD, Lifeline and HAAAD annual income limits adjust to less than **\$26,575** for single persons and to less than **\$32,582** for married persons. The Senior Gold annual income limits for single persons are between **\$26,575** and **\$36,575** and married persons must have annual combined income of between **\$32,582** and **\$42,582**. These income eligibility limits are effective January 1, 2015.

EFFECTIVE JANUARY 1, 2015

The PAAD income eligibility limits for calendar year 2015 are:

Less than **\$26,575** FOR A SINGLE PERSON  
Less than **\$32,582** FOR A MARRIED COUPLE

The SENIOR GOLD income eligibility limits for calendar year 2015 are:

Between **\$26,575-\$36,575** FOR SINGLE PERSONS  
Between **\$32,582-\$42,582** FOR MARRIED PERSONS
