TO: Providers of Pharmaceutical Services

SUBJECT: Eligibility Limits for Calendar Year 2018 for Pharmaceutical Assistance to the Aged and Disabled (PAAD), Lifeline, Hearing Aid Assistance to the Aged and Disabled (HAAAD), and Senior Gold Discount Prescription Programs.

EFFECTIVE: January 1, 2018

PURPOSE: To notify providers, beneficiaries and the general public of the new income eligibility limits for calendar year 2018 for PAAD, Lifeline, HAAAD, and Senior Gold.

BACKGROUND: In accordance with N.J.S.A. 30:4D-21 b, eligibility limits are adjusted each year to reflect the amount of the Social Security cost of living adjustment (COLA).

The COLA for calendar year 2018 is 2%. Based on the COLA, the PAAD, Lifeline and HAAAD annual income limits will be less than **\$27,189** for single persons and less than **\$33,334** for married persons. The Senior Gold annual income limits for single persons will be between **\$27,189** and **\$37,189** and married persons must have annual combined income of between **\$33,334** and **\$43,334**.

EFFECTIVE JANUARY 1, 2018

The PAAD income eligibility limits for calendar year 2018 are:

Less than **\$27,189** FOR A SINGLE PERSON
Less than **\$33,334** FOR A MARRIED COUPLE

The SENIOR GOLD income eligibility limits for calendar year 2018 are:

Between **\$27,189-\$37,189** FOR SINGLE PERSONS
Between **\$33,334-\$43,334** FOR MARRIED PERSONS
