TO: Providers of Pharmaceutical Services

SUBJECT: Eligibility limits for calendar year 2019 for Pharmaceutical Assistance to the Aged and Disabled (PAAD), Lifeline Utility Assistance (Lifeline), Hearing Aid Assistance to the Aged and Disabled (HAAAD), and Senior Gold Prescription Discount (Senior Gold) programs.

EFFECTIVE: January 1, 2019

PURPOSE: To notify providers, beneficiaries and the general public of the new income eligibility limits for calendar year 2019 for PAAD, Lifeline, HAAAD, and Senior Gold.

BACKGROUND: In accordance with N.J.S.A. 30:4D-21b, eligibility limits are adjusted each year to reflect the amount of the Social Security Cost of Living Adjustment (COLA).

The COLA for calendar year 2019 is 2.8%. Based on the COLA, the PAAD, Lifeline and HAAAD annual income limits will be less than **\$27,951** for single persons and less than **\$34,268** for married couples. The Senior Gold annual income limits will be between **\$27,951** and **\$37,951** for single persons and between **\$34,268** and **\$44,268** for married couples.

EFFECTIVE JANUARY 1, 2019

The PAAD income eligibility limits for calendar year 2019 are:

Less than **\$27,951** FOR A SINGLE PERSON

Less than **\$34,268** FOR A MARRIED COUPLE

The SENIOR GOLD income eligibility limits for calendar year 2019 are:

Between **\$27,951-\$37,951** FOR SINGLE PERSONS

Between **\$34,268-\$44,268** FOR MARRIED COUPLES
