SUBJECT: **Clarification of Billing Procedures for Certain Mental Health and Substance Abuse Services**

EFFECTIVE: See Effective Dates As Indicated Below

PURPOSE: To clarify billing procedures for certain mental health services billed by Work First New Jersey (WFNJ) Substance Abuse Initiative (SAI) providers; non-SAI substance abuse providers and independent clinics that specialize in providing mental health services.

BACKGROUND: The New Jersey Family Care (formerly Medicaid) Newsletter, Volume 23, No. 11, dated July 2013, announced 2013 changes in billing procedure codes for certain behavioral health services. Three (3) types of providers are eligible to bill some or all of these mental health services, as well as methadone and narcotic clinic visit procedure codes:

- Independent Clinics specializing in mental health;
- Work First New Jersey (WFNJ) Substance Abuse Initiative (SAI) providers; and
- Non-SAI substance abuse providers.

This Newsletter is intended to identify those procedure codes that may be billed by each provider type.
