TO: Providers of Pharmaceutical Services – **For Action**

SUBJECT: Eligibility limits for calendar year 2023 for the Pharmaceutical Assistance to the Aged and Disabled (PAAD), Lifeline Utility Assistance (Lifeline), Hearing Aid Assistance to the Aged and Disabled (HAAAD), and Senior Gold Prescription Discount (Senior Gold) programs.

EFFECTIVE: January 1, 2023

PURPOSE: To notify providers, beneficiaries and the general public of the new income eligibility limits for calendar year 2023 for PAAD, Lifeline, HAAAD, and Senior Gold.

BACKGROUND: In accordance with N.J.S.A. 30:4D-21b eligibility limits are adjusted each year to reflect the amount of the Social Security Cost of Living Adjustment (COLA).

The COLA for calendar year 2023 is 8.7%. Based on the COLA, the PAAD, Lifeline and HAAAD annual income limits will be less than **\$42,142** for single persons and less than **\$49,209** for married couples. The Senior Gold annual income limits will be between **\$42,142** and **\$52,142** for single persons and between **\$49,209** and **\$59,209** for married couples.

EFFECTIVE JANUARY 1, 2023

The PAAD income eligibility limits for calendar year 2023 are:

Less than **\$42,142** FOR A SINGLE PERSON
Less than **\$49,209** FOR A MARRIED COUPLE

The SENIOR GOLD income eligibility limits for calendar year 2023 are:

Between **\$42,142 - \$52,142** FOR SINGLE PERSONS
Between **\$49,209 - \$59,209** FOR MARRIED COUPLES
