TO: Home Care Services Providers

SUBJECT: Early and Periodic Screening, Diagnosis and Treatment/Private Duty Nursing (EPSDT/PDN) Services

EFFECTIVE: June 1, 1994

BACKGROUND: The 1989 Omnibus Budget Reconciliation Act (OBRA '89) mandates that EPSDT recipients receive the entire scope of Title XIX services, if medically necessary, even when those services are not covered under the State Plan.

It is under this mandate that New Jersey will now provide private duty nursing services through the Early and Periodic Screening, Diagnosis and Treatment (EPSDT) program to EPSDT recipients, under 21 years of age, who live in the community, and whose medical condition and treatment plan justify that need.

PURPOSE:

1. To provide a means of referring eligible individuals for community-based private duty nursing services reimbursed by Medicaid under the Early and Periodic Screening, Diagnosis and Treatment (EPSDT) Program;
2. To explain the mechanisms for determination of approvals; and
3. To explain the process for the prior authorization and initiation of PDN services.

ACTION: Eligible individuals under 21 years of age who are enrolled in the Medicaid program and who require PDN services to allow them to be cared for in a community setting may be referred for EPSDT/PDN services. Individuals with pending SSI eligibility and individuals eligible for Medicaid services through the Medically Needy Program are not eligible for EPSDT/PDN services. (EPSDT is not a covered service under the Medically Needy Program.)

To be considered in need of EPSDT/PDN services, an individual must exhibit a severity of illness that requires complex interventions by licensed nursing personnel on an ongoing basis, i.e. 24 hours a day, making the care continuous rather than intermittent.

EPSDT/PDN services are only appropriate for those cases where:

1. There is a capable adult primary caregiver residing with the individuals who accepts ongoing 24-hour responsibility for the health and welfare of the recipient;
2. The primary caregiver agrees to provide a minimum of eight (8) hours of hands-on care to the individual in any 24-hour period; and
3. The home environment can accommodate the required equipment and licensed PDN personnel.

The determination of the total PDN hours approved, up to sixteen (16) hours a day, will take into account alternative sources of care available to the family (e.g. medical day care, PDN services covered by a private insurer, etc.). The total, alternative care and approved EPSDT/PDN hours, shall not exceed sixteen (16) hours per day. An exception to the rule will be granted only in an extreme situation, such as a hospitalization of the sole caregiver.

Individuals who may be appropriate for EPSDT/PDN services can be referred by a parent, primary physician, hospital discharge planner, Special Child Health Services case manager or current PDN provider. Requests for services must be submitted to the Medicaid District Office (MDO) in the county where the child is currently located using a "Request for EPSDT Private Duty Nursing Services (FD-389)" form. The Request must be completed and signed by a physician and agreed to and signed by a parent or guardian. All sections of the Request must be completed and a physician's case summary and current treatment plan must be attached. Incomplete Requests will be returned to the referral source for completion prior to any action by the Medicaid agency.

PLEASE NOTE: For individuals enrolled in a Managed Care Program, the Physician Case Manager (PCM) will determine the need and approve the PDN services. For children enrolled in the Garden State Health Plan, the "Garden State Health Plan Authorization Form (GSHP-7)" form must be used.

Upon receipt of the fully completed Request (FD-389), the Medicaid Regional Staff Nurse (RSN) will conduct an assessment of the need for PDN services, as well as the level (LPN or RN) and amount of service required. A letter notifying the family and the person who referred the individual of the decision following the RSN's assessment will be issued by the MDO on the "Medicaid District Office Authorization/Approval/Denial Form (FD-390)(1/94)." The number of hours approved, the level of services, and the length of time of the approval (up to a maximum of six (6) months) will be noted on the form.

If the PDN provider has already been selected, the MDO staff working in conjunction with a hospital discharge planner will create an active PA record for the individual. This will allow for immediate PDN service provision and billing at the time of the individual's hospital discharge. Telephone requests for prior authorization (PA) can be accommodated in an emergency but must be followed by a written request.

If the prospective PDN provider has not yet been selected at the time of the assessment and approval of the need for PDN services, the PDN agency, when selected, must submit a request to the MDO for the PDN services on the "Prior Authorization Request Form (FD-365)(9/91)" which contains a pre-printed prior authorization (PA) number.

The Prior Authorization (PA) and billing processes also apply to PDN providers servicing children enrolled in the Garden State Health Plan. For services provided to these individuals, the PDN provider must also include the PA number from the "Garden State Health Plan Authorization Form (GSHP-7)" in FIELD 34 on the 1500 N.J. claim form.

NOTE: Although the prior authorization (PA) process applies to EPSDT/PDN and GSHP recipients, the PA process does not apply to recipients in the Model Waiver III or AIDS Community Care Alternative Program (ACCAP) programs except when more than 16 hours a day of PDN services are required. (Refer to Newsletter, Volume 4, No.15, March 1994.)

Requests for continuation, or modification of PDN services during the treatment period, must be submitted by the PDN agency, in writing, to the MDO on the "Prior Authorization Request Form (FD-365)(9/91)." In an emergency, requests for modification of services may be made by telephone but must be followed by a written prior authorization (PA) request.

Claims for payment for PDN services are submitted to Unisys using the Health Insurance Claim Form (1500 N.J.)(5/93). The PA number from the "Medicaid District Office Authorization/Approval/Denial Form (FD-390)(1/94)" must be noted on the claim form. Providers must bill each date of service on a separate line (FIELD 24A) of the claim form. If more than one procedure code is billed for the same date of services, separate lines must be used when billing each procedure code. Do not span dates of service on a line of the claim form.

Private Duty Nursing provider fees vary but reimbursement cannot exceed the maximum rates allowed by the Program.

The following procedure codes apply:

NOTE: The "WT" modifier represents EPSTD/PDN services only. Do not use this modifier for PDN services through any other program.

EPSTD/PDN providers must submit to the MDO, every 2 months, comprehensive clinical summaries reflecting the recipient's medical status and need for on-going services. The MDO staff will review the submitted clinical data and may conduct on-site home visits before reauthorizing PDN services. In addition, MDO staff will perform Home Care Quality Assurance Reviews of these individuals. In accordance with N.J.A.C. 10:60-1.16, the Office of Home Care Programs will continue on-site monitoring of private duty nursing agencies to review compliance with personnel, recordkeeping and service requirements.
