SUBJECT: Closing the Bergen Medicaid District Office (MDO)

EFFECTIVE: May 17, 1996

PURPOSE: To alert providers that effective May 17, 1996 the Bergen Medicaid District Office (MDO) will be closed and the work activities conducted at the Bergen MDO will be reassigned to the Passaic MDO.

BACKGROUND: With the advent of changes to the New Jersey Medicaid program, as a consequence of the development, introduction, and progress of a managed care health services program, as well as attrition-driven staff reductions, it is imperative that existing resources be consolidated into a more manageable organization. As a result, the Bergen MDO will be closed effective May 17, 1996. The prior authorization (PA) services will be reassigned to the Passaic MDO, which will provide PA services for Passaic, Bergen and Hudson Counties.

The impact on the provider community is expected to be minimal in that they will continue to be served by an MDO in a nearby county.

ACTION: All Bergen County and Hudson County providers who routinely require prior authorization from an MDO should forward such requests to the Passaic MDO for processing, effective May 17, 1996. Attached is a list of MDOs; this replaces Form #17 in the Appendix to 10:49.

NOTE: This has no impact on those prior authorization requests routinely submitted to the Division's Central Office in Trenton.

The Hudson MDO will continue to specialize in all PreAdmission Screening/Long-Term Care activities. Hospitals and Nursing Facilities (NFs) in Bergen County should continue to refer requests for PreAdmission Screening Assessments (PAS) to the Hudson MDO.

Questions of a general nature about procedures, eligibility, etc., should be referred to the MDO serving the county in which the beneficiary is located. Bergen County providers/beneficiaries should contact the Passaic MDO.

Attached for your reference is a directory of the MDOs, their addresses and telephone numbers.
