SUBJECT: **Changes in Billing Procedures for Adult Mental Health Rehabilitative (AMHR) Services**

EFFECTIVE: Claims with service dates on or after April 1, 2018

PURPOSE: To notify providers of behavioral health services of a decision by the New Jersey Division of Medical Assistance and Health Services (DMAHS) and the New Jersey Division of Mental Health and Addiction Services (DMHAS) to change billing procedures for Adult Mental Health Rehabilitative (AMHR) services.

ACTION:

(1) **As announced in the DMAHS/DMHAS Newsletter Volume 26, No. 05, providers requesting payments for AMHR services must bill the AMHR procedure codes listed in Table A for claims with dates of service on or after July 1, 2016.**
